# Metropolitan Topeka Airport Authority November 17, 2021

Chairman, Thomas Wright, brought the regular monthly meeting of the MTAA Board of Directors to order at 9:00 AM with the following Board members present: Mike Munson, Lisa Stubbs and Brian Armstrong with Erica Garcia-Babb via telephone conference. Also in attendance were:

Other staff members present were Eric Johnson, Cheryl Trobough and Danielle Sheehy.

#### Item 1. Notice.

Chairman Wright inquired if everyone who requested notification had been notified of this meeting. Ms. Trobough replied that notifications were sent.

Item 2. Approve Minutes of the MTAA's Regularly Scheduled Board Meetings of October 19, 2021. Chairman Wright asked the Board to review the Minutes of the Regularly Scheduled Board Meeting held on October 19, 2021 and inquired if there were any additions, corrections or comments to the Minutes.

Mr. Munson stated that he remembers Mr. Armstrong inquiring about the progress on the Heinen Aviation activities at Billard Airport and he requested an amendment to the minutes to reflect the information.

Mr. Munson moved to approve the Minutes of the Regularly Scheduled Board Meeting of October 19, 2021 as amended. Ms. Stubbs seconded the motion. Motion carried.

## Item 3. Public Comment

Chairman Wright inquired if there was anyone registered to speak during Public Comment. Mr. Johnson replied that there was not.

#### Item 4. Adopt the Agenda.

Chairman Wright inquired if there were any changes to the Agenda as presented. Mr. Johnson requested the addition of an item to consider a quote for necessary asbestos and lead paint abatement. Chairman Wright added the item as Agenda Item 9.a.

Ms. Stubbs made a motion to adopt the Agenda as amended. Mr. Munson seconded the motion. Motion carried.

# Item 5. Consider Approval of WSP USA, Inc., Agreement No. 30900280 - Task Order No. 5 CARES Act Funding Program – FOE Fuel Farm Design Services.

Mr. Johnson reported As you know, the MTAA received a CARES Act grant of nearly \$17 Million dollars for projects identified in our On-Call agreement with WSP USA, Inc. The Fuel Farm at Topeka Regional Airport is one of several projects specifically included in the agreement because of this grant.

Task Order No. 5 will encompass civil and mechanical engineering for the design of the Fuel Storage Facility as well as the removal of the existing fuel facility. The new facility will provide storage for 100,000 useable gallons of Jet fuel, 12,000 gallons of avgas along with mechanical, electrical and environmental controls. WSP USA, Inc. with selected subconsultants will provide design services for this project. Construction observation services are not included in this task order and, if required, will be negotiated at a later date.

I request the Board approve WSP USA, Inc., Task Order No. 5 – FOE Bulk Fuel Storage and Loading/Unloading Facility, in the total amount of \$473,884.00, subject to the completion of the Independent Fee Estimate (IFE) and FAA approval. The CARES Act grant funds 100% of the cost with 0% local participation.

Mr. Munson made a motion to approve Task Order No. 5 – FOE Fuel Farm Design Services as submitted by WSP USA, Inc. in the total amount of Four Hundred Seventy-Three Thousand Eight Hundred Eighty-Four Dollars (\$473,884.00) subject to staff's completion of the Independent Fee Estimate and FAA approval. Ms. Stubbs seconded the motion. Motion carried with Mr. Armstrong abstaining from the vote due to a conflict of interest.

# Item 6. Election of Officers for December 2021 through November 2022.

Chairman Wright offered a slate of officers for 2022 for discussion as follows:

Mike Munson – Chairman; Lisa Stubbs – Vice-Chair; and Brian Armstrong – Secretary.

Chairman Wright made a motion to approve the slate as presented. Ms. Stubbs seconded the motion. Motion carried.

Chairman-Elect Munson presented Mr. Wright with an engraved gavel and thanked him for his service as MTAA Board Chairman for 2021.

Item 7. Consider Resolution No. 21-278 for Authorization of Depository Signatures; and Resolution No. 21-279 for Authorization of Certificates of Deposit Signatures at All Shawnee County Financial Institutions.

Ms. Trobough explained that with the election of a new chairman, the Board of Directors needs to review and approve Resolutions as follows:

- 1. Resolution No. 21-278 for Certification of Authorization of signatures on the bank accounts at Fidelity State Bank & Trust;
- 2. Resolution No. 21-279 to designate signatures for the Certificates of Deposit.

Mr. Munson made a motion to adopt Resolution No. 21-278 and No. 21-279 as presented. Mr. Armstrong seconded the motion. Motion carried.

# Item 8. Consider Approval of MTAA Resolution No. 21-280 Authorizing the Acceptance of Airport Rescue Grant Offer No. 3-20-0113-043-2022 Through Federal Aviation Administration.

Mr. Johnson reported that the Federal Aviation Administration (FAA) recently offered a (100%) grant to provide eligible sponsors with funding for costs related to operations, personnel, cleaning, sanitization, janitorial services, and combating the spread of pathogens at the airport. A project to enlarge the sterile area of the terminal building at Topeka Regional Airport was submitted and approved by the FAA. This grant will fund the project to enclose the WiFi lounge in the terminal building and open the area to the Sterile area. Doing so will nearly double the occupancy of the area and allow for social distancing.

Mr. Johnson requested the Board of Directors to authorize staff to accept the Airport Rescue Grant in the amount of \$1,057,039. Staff is required to advertise a request for qualification for architects interested in designing, bidding and overseeing this project. Again, the project is 100% funded by the FAA with no matching obligation of MTAA funds.

Ms. Stubbs made a motion to adopt MTAA Resolution No. 21-280 authorizing Eric Johnson to sign the Airport Rescue grant offer from the FAA in the amount of One Million Fifty-Seven Thousand Thirty-Nine Dollars (\$1,057,039) for AIP Project 3-20-0113-043-2020. Mr. Munson seconded the motion. Motion carried.

# Item 9. Consider Purchase of 2021 Budgeted Equipment – Compact Track Loader.

Mr. Johnson reported that a compact track loader acquisition was included in the 2021 budget. Staff researched equipment from various manufacturers and discovered through working with the Kansas State procurement officer that John Deere had the state contract on various models but not the one model identified as best suited for MTAA needs. The local John Deere representative presented two options for consideration. They offer a standard government discount price for the John Deere 325G compact track loader. This price is discounted 13% off the retail price that would be available to the public. The other option available to all governmental entities is the Sourcewell Collabrative discount program. Only accepted municipal entities can participate in this program and it offers 19% off retail pricing. Staff has made application to Sourcewell and the membership and was granted.

The Sourcewell quote for the 325G compact track loader is \$ 60,824.15. This is \$4,332.67 less than the standard government price.

Mr. Johnson requested authorization to purchase a John Deere 325G compact track loader through the Sourcewell contract at a cost of \$60,824.15.

Mr. Armstrong made a motion to approve the Sourcewell purchase of a John Deere 32G compact track loader at a cost not to exceed Sixty Thousand Eight Hundred Twenty-Four Dollars and Fifteen Cents (\$60,824.15). Mr. Munson seconded the motion. Motion carried.

# Item 9.a. Consider Quote Regarding Asbestos and Lead Paint Abatement at 6331 SE Forbes Ave. (Bldg. 186), and 5317 SE California Ave. (Abandoned Military Communications Bldg.)

Mr. Johnson reported that prior to remodeling or rehabilitating buildings in preparation for a lease, it has been the goal to address any asbestos identified in the building. There is remodeling work planned in the MTAA Maintenance building, so addressing the asbestos throughout the building needs to be completed.

There is a second building that has not been used in many years. It is a concrete structure located on the Southwest corner of SE 53<sup>rd</sup> and SE California Ave. The building is not usable in its present condition and is not worth renovation. The FAA has some other equipment nearby and have reported to us that it appears people are trespassing on the property and causing damage. A quote was obtained for asbestos and lead paint abatement. The contractor will also demolish the abandoned building and haul all waste material from the site for proper disposal. Jacobson Asbestos Company provided a quote for both locations:

Mr. Johnson requested the Board authorize the removal of the asbestos material and lead paint as well as the demolition of the building at a cost of \$56,755.00.

Mr. Munson made a motion to contract with Jacobson Asbestos Company for the removal of the asbestos material and lead paint prior to demolishing the building at the quoted cost not to exceed Fifty-six Thousand Seven Hundred Fifty-five Dollars and No Cents (\$56,755.00). Mr. Armstrong seconded the motion. Motion carried.

Item 10. Monthly Reports

#### 10.a. Aviation-Related Issues & Air Service - Mr. Johnson

Mr. Johnson provided the following report:

- The FAA completed the annual Part 139 inspection last week. Overall, it was a good inspection. There are a couple of record keeping items to correct and a few items with the FBO. Staff will be working to have these items address prior to the completion date identified by the FAA.
- Staff is in the process of updating the Airport Capital Improvement Program at both airports for the FAA. This is completed annually to prepare for AIP funds for eligible projects.
- Staff is continuing to work on the TOP Terminal Design independent fee estimate. There are differences in the IFE interpretation of the project and staff is currently in negotiations with the consultants to better define the missing elements.
- The drainage projects at Bldg. 612 and behind the Police/Fire Station at Bldgs. 621/623 are waiting on the completion of the surveys.

#### 10.b. Economic Development & Leasing Activity – Mr. Johnson

Mr. Johnson provided the following report:

## 10.c. Monthly Financial Reports – Ms. Trobough

Ms. Trobough provided the following report:

- The report for the month ending <u>10/30/2021</u> reflects revenue to be \$291,724 ahead of the budget which is a net result from:
  - a. Taxes and Assessments receipts reflect to be \$28,295 less than the anticipated budgeted;
  - b. Landing Fees income shows to be \$26,048 less than budgeted;
  - c. Fuel Flowage Fees are \$32,382 more than the anticipated budgeted;
  - d. Passenger Facility Charges are under budget by \$8,327;
  - e. Lease & Rental Fees actual income is \$211,595 more than budgeted;
  - f. Reimbursements total to be \$32,661 more than budgeted;
  - g. CD Interest income is \$3,055 under budget;
  - h. Water/Sewer Sales are \$57,871 more than budgeted with Water/Sewer Costs reflecting to be \$57,237 more than the budgeted costs.
- Overall, the operating expenses ended the year with a favorable budget variance of \$535,084.
- Capital Improvement purchases made during the month of June are as follows:
  - a. EMERGENCY NEEDS Payment of \$16,509.00 for the first emergency repair on the AOA power outage which affected the ILS power;
  - b. VEHICLES An additional cost of \$8,827.00 was added to the values of the Board-approved pickups purchased for the exterior wrap on the RAM Patrol Truck and purchase and installation of radio equipment for the Maintenance trucks.

Mr. Munson moved to accept and file the Monthly Financial Reports as presented for the month ended October 31, 2021. Mr. Armstrong seconded the motion. Motion carried.

#### Item 11. Executive Session

Chairman Wright inquired if there was a need for an Executive Session. Mr. Resner and Mr. Johnson responded that there was not.

#### Adjournment

Ms. Stubbs inquired about the annual Board Holiday Dinner. After a brief discussion, it was the consensus of the Board to make a reservation at The Blue Moose on Tuesday, December 14, 2021.

Chairman Wright asked if there was any further business to discuss, hearing none, he asked for a motion to adjourn. Ms. Stubbs made the motion to adjourn. Mr. Munson seconded the motion and the meeting was adjourned at 9:46 a.m.

Please find the following electronic Airport Rescue Grant Offer, Grant No. 3-20-0082-025-2022 for Philip Billard Municipal Airport. This letter outlines expectations for success. Please read and follow the instructions carefully.

To properly enter into this agreement, you must do the following:

- a. The governing body must provide authority to execute the grant to the individual signing the grant; i.e., the sponsor's authorized representative.
- b. The sponsor's authorized representative must execute the grant, followed by the attorney's certification, **no later than January 15**, in order for the grant to be valid.
- c. You may not make any modification to the text, terms or conditions of the grant offer.
- d. The grant offer must be digitally signed by the sponsor's legal signatory authority and then the grant offer will be routed via email to the sponsor's attorney. Once the attorney has digitally attested to the grant, an email with the executed grant will be sent to all parties.

Subject to the requirements in 2 CFR § 200.305, each payment request for reimbursement under this grant must be made electronically via the Delphi elnvoicing System. Please see the attached Grant Agreement for more information regarding the use of this System. The terms and conditions of this agreement require you draw down and expend these funds within four years.

An airport sponsor may use these funds for costs related to operations, personnel, cleaning, sanitization, janitorial services, combating the spread of pathogens at the airport, and debt service payments. Please refer to the <u>Airport Rescue Grants Frequently Asked Questions</u> for further information.

With each payment request you are required to upload an invoice summary directly to Delphi. The invoice summary should include enough detail to permit FAA to verify compliance with the American Rescue Plan Act (Public Law 117-2). Additional details or invoices may be requested by FAA during the review of your payment requests.

As part of your final payment request, you are required to include in Delphi:

- A signed SF-425, Federal Financial Report
- A signed closeout report (a sample report is available <u>here</u>).

Until the grant is completed and closed, you are responsible for submitting a signed and dated SF-425 annually, due 90 days after the end of each Federal fiscal year in which this grant is open (due December 31 of each year this grant is open).

As a condition of receiving Federal assistance under this award, you must comply with audit requirements as established under 2 CFR part 200. Subpart F requires non-Federal entities that expend \$750,000 or more in Federal awards to conduct a single or program specific audit for that year. Note that this includes Federal expenditures made under other Federal-assistance programs. Please take appropriate and necessary action to assure your organization will comply with applicable audit requirements and standards.

I am readily available to assist you and your designated representative with the requirements stated herein. The FAA sincerely values your cooperation in these efforts.

#### **GRANT AGREEMENT**

#### Part I - Offer

FROM: The United States of America (acting through the Federal Aviation Administration, herein called the "FAA")

WHEREAS, the Sponsor has submitted to the FAA an Airports Rescue Grant Application dated July 20, 2021, for a grant of Federal funds at or associated with the Philip Billard Municipal Airport, which is included as part of this Airport Rescue Grant Agreement;

WHEREAS, the Sponsor has accepted the terms of FAA's Airport Rescue Grant offer;

WHEREAS, in consideration of the promises, representations and assurances provided by the Sponsor, the FAA has approved the Airport Rescue Grant Application for the Philip Billard Municipal Airport, (herein called the "Grant" or "Airport Rescue Grant") consisting of the following:

WHEREAS, this Airport Rescue Grant is provided in accordance with the American Rescue Plan Act ("ARP Act", or "the Act"), Public Law 117-2, as described below, to provide eligible Sponsors with funding for costs related to operations, personnel, cleaning, sanitization, janitorial services, combating the spread of pathogens at the airport, and debt service payments. Airport Rescue Grant amounts to specific airports are derived by legislative formula (See Section 7102 of the Act).

WHEREAS, the purpose of this Airport Rescue Grant is to prevent, prepare for, and respond to the coronavirus pandemic. Funds provided under this Airport Rescue Grant Agreement must be used only for purposes directly related to the airport. Such purposes can include the reimbursement of an airport's operational expenses or debt service payments in accordance with the limitations prescribed in the Act. Airport Rescue Grants may be used to reimburse airport operational expenses directly related to Philip Billard Municipal Airport incurred no earlier than January 20, 2020.

Airport Rescue Grants also may be used to reimburse a Sponsor's payment of debt service where such payments occur on or after March 11, 2021. Funds provided under this Airport Rescue Grant Agreement will be governed by the same principles that govern "airport revenue." New airport development projects not directly related to combating the spread of pathogens may not be funded with this Grant. Funding under this Grant for airport development projects to combat the spread of pathogens will be reallocated using an addendum to this Agreement for identified and approved projects.

THE FEDERAL AVIATION ADMINISTRATION, FOR AND ON BEHALF OF THE UNITED STATES, HEREBY OFFERS AND AGREES to pay 100% percent of the allowable costs incurred as a result of and in accordance with this Grant Agreement.

- 2. <u>Grant Performance</u>. This Airport Rescue Grant Agreement is subject to the following Federal award requirements:
  - a. The Period of Performance:
    - 1. Shall start on the date the Sponsor formally accepts this agreement, and is the date signed by the last Sponsor signatory to the agreement. The end date of the period of performance is 4 years (1,460 calendar days) from the date of acceptance. The period of performance end date shall not affect, relieve, or reduce Sponsor obligations and assurances that extend beyond the closeout of this Grant Agreement.
    - 2. Means the total estimated time interval between the start of an initial Federal award and the planned end date, which may include one or more funded portions, or budget periods. (2 Code of Federal Regulations (CFR) § 200.1)
  - b. The Budget Period:
    - 1. For this Airport Rescue Grant is 4 years (1,460 calendar days). Pursuant to 2 CFR § 200.403(h), the Sponsor may charge to the Grant only allowable costs incurred during the budget period.
    - 2. Means the time interval from the start date of a funded portion of an award to the end date of that funded portion during which the Sponsor is authorized to expend the funds awarded, including any funds carried forward or other revisions pursuant to §200.308.

- c. Close out and Termination.
  - 1. Unless the FAA authorizes a written extension, the Sponsor must submit all Grant closeout documentation and liquidate (pay-off) all obligations incurred under this award no later than 120 calendar days after the end date of the period of performance. The Sponsor must carry out and complete the Grant without undue delays and in accordance with this Airport Rescue Grant Agreement, the ARP Act, and the regulations, policies, standards, and procedures of the Secretary of Transportation ("Secretary"). Pursuant to 2 CFR § 200.308, the Sponsor agrees to report to the FAA any disengagement from funding eligible expenses under the Grant that exceeds three months or a 25 percent reduction in time devoted to the Grant, and request prior approval from FAA. The report must include a reason for the stoppage. The Sponsor agrees to comply with the attached assurances, which are part of this agreement and any addendum that may be attached hereto at a later date by mutual consent.
- 7. <u>Amendments or Withdrawals before Grant Acceptance</u>. The FAA reserves the right to amend or withdraw this offer at any time prior to its acceptance by the Sponsor.
- 8. <u>Offer Expiration Date</u>. This offer will expire and the United States will not be obligated to pay any part of the costs unless this offer has been accepted by the Sponsor on or before January 15, or such subsequent date as may be prescribed in writing by the FAA.
- 9. Improper Use of Federal Funds. The Sponsor must take all steps, including litigation if necessary, to recover Federal funds spent fraudulently, wastefully, or in violation of Federal antitrust statutes, or misused in any other manner, including uses that violate this Airport Rescue Grant Agreement, the ARP Act, or other provision of applicable law. For the purposes of this Airport Rescue Grant Agreement, the term "Federal funds" means funds however used or dispersed by the Sponsor that were originally paid pursuant to this or any other Federal grant agreement(s). The Sponsor must return the recovered Federal share, including funds recovered by settlement, order, or judgment, to the Secretary. The Sponsor must furnish to the Secretary, upon request, all documents and records pertaining to the determination of the amount of the Federal share or to any settlement, litigation, negotiation, or other efforts taken to recover such funds. All settlements or other final positions of the Sponsor, in court or otherwise, involving the recovery of such Federal share require advance approval by the Secretary.

- 10. <u>United States Not Liable for Damage or Injury</u>. The United States is not responsible or liable for damage to property or injury to persons which may arise from, or relate to this Airport Rescue Grant Agreement, including, but not limited to, any action taken by a Sponsor related to or arising from, directly or indirectly, this Airport Rescue Grant Agreement.
- 11. System for Award Management (SAM) Registration and Unique Entity Identifier (UEI).
  - a. Requirement for System for Award Management (SAM): Unless the Sponsor is exempted from this requirement under 2 CFR 25.110, the Sponsor must maintain the currency of its information in SAM until the Sponsor submits the final financial report required under this Grant, or receives the final payment, whichever is later. Upon request of the FAA, the Sponsor shall provide one copy of the completed audit to the FAA.

- 17. <u>Suspension or Debarment</u>. When entering into a "covered transaction" as defined by 2 CFR § 180.200, the Sponsor must:
  - a. Verify the non-Federal entity is eligible to participate in this Federal program by:
    - Checking the excluded parties list system (EPLS) as maintained within the System for Award Management (SAM) to determine if the non-Federal entity is excluded or disqualified; or

#### 18. Ban on Texting While Driving.

  - 1. Adopt and enforce workplace safety policies to decrease crashes caused by distracted drivers including policies to ban text messaging while driving when performing any work for, or on behalf of, the Federal government, including work relating to this Airport Rescue Grant or subgrant funded by this Grant.
  - 2. Conduct workplace safety initiatives in a manner commensurate with the size of the business, such as:
    - A. Establishment of new rules and programs or re-evaluation of existing programs to prohibit text messaging while driving; and
    - B. Education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
- b. The Sponsor must insert the substance of this clause on banning texting while driving in all subgrants, contracts, and subcontracts funded by this Airport Rescue Grant.

#### 19. Trafficking in Persons.

- a. You as the recipient, your employees, subrecipients under this Airport Rescue Grant, and subrecipients' employees may not
  - 1. Engage in severe forms of trafficking in persons during the period of time that the award is in effect;
  - 2. Procure a commercial sex act during the period of time that the award is in effect; or
  - 3. Use forced labor in the performance of the award or subawards under the Airport Rescue Grant.
- b. The FAA as the Federal awarding agency may unilaterally terminate this award, without penalty, if you or a subrecipient that is a private entity

- A. Associated with performance under this Airport Rescue Grant; or
- B. Imputed to the subrecipient using the standards and due process for imputing the conduct of an individual to an organization that are provided in 2 CFR Part 180, "OMB Guidelines to Agencies on Government-wide Debarment and Suspension (Nonprocurement)," as implemented by the FAA at 2 CFR Part 1200.
- c. You must inform us immediately of any information you receive from any source alleging a violation of a prohibition in paragraph a. of this Grant condition during this Airport Rescue Grant Agreement.
- d. Our right to terminate unilaterally that is described in paragraph a. of this Grant condition:
  - 1. Implements section 106(g) of the Trafficking Victims Protection Act of 2000 (TVPA), as amended (22 U.S.C. § 7104(g)), and
  - 2. Is in addition to all other remedies for noncompliance that are available to the FAA under this Airport Rescue Grant.

# 20. Employee Protection from Reprisal.

- a. Prohibition of Reprisals
  - 1. In accordance with 41 U.S.C. § 4712, an employee of a grantee or subgrantee may not be discharged, demoted, or otherwise discriminated against as a reprisal for disclosing to a person or body described in sub-paragraph (a)(2) of this Grant condition, information that the employee reasonably believes is evidence of:
    - a. Gross mismanagement of a Federal grant;
    - b. Gross waste of Federal funds;
    - c. An abuse of authority relating to implementation or use of Federal funds;

- 5. Required Actions of the Inspector General Actions, limitations, and exceptions of the Inspector General's office are established under 41 U.S.C. § 4712(b).
- 6. Assumption of Rights to Civil Remedy Upon receipt of an explanation of a decision not to conduct or continue an investigation by the Office of Inspector General, the person submitting a complaint assumes the right to a civil remedy under 41 U.S.C. § 4712(c).
- 21. <u>Limitations</u>. Nothing provided herein shall be construed to limit, cancel, annul, or modify the terms of any Federal grant agreement(s), including all terms and assurances related thereto, that have been entered into by the Sponsor and the FAA prior to the date of this Airport Rescue Grant Agreement.
- 22. Face Coverings Policy. The sponsor agrees to implement a face-covering (mask) policy to combat the spread of pathogens. This policy must include a requirement that all persons wear a mask, in accordance with Centers for Disease Control (CDC) and Transportation Security Administration (TSA) requirements, as applicable, at all times while in all public areas of the airport property, except to the extent exempted under those requirements. This special condition requires the airport sponsor continue to require masks until <a href="Executive Order 13998">Executive Order 13998</a>, <a href="Promoting COVID-19 Safety">Promoting COVID-19 Safety</a> in Domestic and <a href="International Travel">International Travel</a>, is no longer effective.

#### SPECIAL CONDITIONS FOR USE OF AIRPORT RESCUE GRANT FUNDS

#### **CONDITIONS FOR EQUIPMENT -**

- 1. **Equipment or Vehicle Replacement.** The Sponsor agrees that when using funds provided by this Grant to replace equipment, the proceeds from the trade-in or sale of such replaced equipment shall be classified and used as airport revenue.
- 2. <u>Equipment Acquisition</u>. The Sponsor agrees that for any equipment acquired with funds provided by this Grant, such equipment shall be used solely for purposes directly related to combating the spread of pathogens at the airport.
- 3. <u>Low Emission Systems</u>. The Sponsor agrees that vehicles and equipment acquired with funds provided in this Grant:
  - a. Will be maintained and used at the airport for which they were purchased; and
  - b. Will not be transferred, relocated, or used at another airport without the advance consent of the FAA.

The Sponsor further agrees that it will maintain annual records on individual vehicles and equipment, project expenditures, cost effectiveness, and emission reductions.

#### **CONDITIONS FOR UTILITIES AND LAND -**

- 4. <u>Utilities Proration</u>. For purposes of computing the United States' share of the allowable airport operations and maintenance costs, the allowable cost of utilities incurred by the Sponsor to operate and maintain airport(s) included in the Grant must not exceed the percent attributable to the capital or operating costs of the airport.
- 5. **Utility Relocation in Grant.** The Sponsor understands and agrees that:

- a. The United States will not participate in the cost of any utility relocation unless and until the Sponsor has submitted evidence satisfactory to the FAA that the Sponsor is legally responsible for payment of such costs;
- b. FAA participation is limited to those utilities located on-airport or off-airport only where the Sponsor has an easement for the utility; and
- c. The utilities must serve a purpose directly related to the Airport.

The Sponsor's acceptance of this Offer and ratification and adoption of the Airport Rescue Grant Application incorporated herein shall be evidenced by execution of this instrument by the Sponsor. The Offer and Acceptance shall comprise an Airport Rescue Grant Agreement, as provided by the ARP Act, constituting the contractual obligations and rights of the United States and the Sponsor with respect to this Grant. The effective date of this Airport Rescue Grant Agreement is the date of the Sponsor's acceptance of this Offer.

Fighting (ARFF) Equipment. (Board Action Required)



Date: December 14, 2021

During the May 2021 meeting, the Board approved the bids for the purchase of the 3,000-Gallon Aircraft Rescue Fire Fighting (ARFF) Vehicle and the ancillary equipment for the new apparatus. We expected both purchases would be covered through funds provided by the FAA's Airport Improvement Program (AIP). While the ARFF Vehicle did meet AIP requirements, the equipment did not.

The AIP "Buy American" section contained within the grant agreement requires manufacturers to provide documentation that the equipment meets the requirement. None of the manufacturers were willing to provide this. For this reason, the FAA denied the purchase.

We initially budgeted funds to pay the local match of the AIP grant however, the FAA waived the local match and funded the truck fully. We have \$100,000.00 available in Line Item 98100. Encumbered funds can be used for the balance.

It is my recommendation the Board authorize staff to purchase the Ancillary Equipment from Danko Emergency Equipment at a total cost of One Hundred Ten Thousand Eight Hundred Fifty-Nine Dollars and Fourteen Cents (\$110,859.14).
