#### **DISCUSSION POINTS**

#### 1. Introductions

#### 2. Project Overview

- WSP provided an overview of the project, noting that it is a 90-day contract with a bid opening on the 20th. Bid opening date updated per addendum
- The project scope includes milling, overlay, patching, crack sealing, thermoplastic emulsion tar slurry coat seal, drainage improvements, and tie-down removals and installations.
- The existing chip seal will be covered with a new chip seal.
- The existing compass rose will not be replaced.
- The concrete mix for tie-down anchors can be changed to a KDOT mix.
- Contractor will supply necessary low-profile barricades.



#### 3. Schedule

- The project is scheduled to be completed in 90 days and is why the bid opening date has changed.
- The FAA has requested that bids be held until July 1st to allow for funding to be secured.
- Construction is anticipated to begin in July/August.

#### 4. Bid Package

- The bid package requires a 5% bid bond, performance and payment bonds, and a completed proposal form.
- There is a DBE percent goal of 9%.
- The Buy American Clause applies to this project.
  - The importance of checking the appropriate boxes on the proposal form related to the Buy American Clause was emphasized.

#### 5. Liquidated Damages

- Liquidated damages are \$1,500 per day.
- It was clarified that liquidated damages apply to the full 90-day contract, not individual phases.

#### 6. Payment

 Payment will be submitted monthly based on quantities installed and confirmed by inspectors.

#### 7. On-Site Supervision

• A designated project supervisor from the prime contractor must be on-site at all times.

#### 8. Badging

- Badging will not be required for workers on this project.
- However, a safety class will be held to remind workers of airport safety and security protocols and FOD management.

#### 9. Permits

 The contractor is responsible for obtaining all permits except for the SWPPP permit, which will be transferred to the contractor.

#### 10. Inspection

- WSP will provide full-time on-site inspection.
- The contractor is responsible for quantity tracking and adherence to the plans and project manual.



#### 11. Last Day for Questions

 The last day for bidders to submit questions is March 17, 2025. To be updated with new bid opening date.

#### 12. Wage Rates

The project is subject to Davis-Bacon wage rates.

#### 13. Safety

- The contractor must submit a safety plan compliance document and adhere to the CSPP Construction Safety Phasing Plan.
- A clean site must be maintained at all times.

#### 14. Air Spacing Analysis

• An air spacing analysis will be conducted to ensure that construction equipment does not interfere with aircraft operations using 20ft.

#### 15. Construction Phasing

- The contractor expressed concern about the constructability of Phase 1A and 1B, suggesting that it would be better to come in from Phase 2.
  - o WSP send further clarification at a future date.
- The contractor asked if Phase 2 can be constructed last.
  - WSP send further clarification at a future date.

#### 16. Asphalt Patching

- The contractor asked about the use of flowable fill in asphalt patching.
  - o It was clarified that flowable fill will not be used in the chip seal area.

#### 17. Mobilization

- The contractor pointed out a discrepancy in the front-end documents regarding the mobilization percentage.
  - WSP send further clarification at a future date.

#### 18. Bid Items

- The contractor requested that a bid item be added for surveying.
  - WSP send further clarification at a future date.
- The contractor requested that a bid item be added for the Contractor Quality Control Plan.
  - WSP send further clarification at a future date.

#### 19. Other

- The closure of Taxiway Echo during phases 1a and 1b will be detailed in an addendum.
- WSP will verify milling depths to ensure adherence to standard thickness specifications and to mitigate potential bonding issues between new and existing pavement. This verification also addresses concerns regarding the structural integrity of the base under construction traffic.
  - o WSP send further clarification at a future date.
